

# Water district renews support of LivingWise conservation program

At November's regular meeting the Board of the Mammoth Community Water District approved continuing its \$3,500 co-sponsorship of the LivingWise water conservation and energy efficiency program for Mammoth Middle School sixth grade earth science students.

Also sponsoring the program is the Eastern Sierra Energy Initiative, a Southern California Edison community energy partnership that is managed by the High Sierra Energy Foundation.

In his comments to the board, Rick Phelps, Executive Director of the High Sierra Energy Foundation, pointed out that "this is an exciting program for the students, because not only does it educate, but it results in real savings.

In fact in 2009 about 425,000 gallons of water and 45,000 kilowatt hours of electricity were saved based on the actions of the students in their homes."

Tom Smith, chair of the Water District Board, saluted the "enthusiastic and creative leadership" of High Sierra Energy Foundation's program manager Leslie O'Berry as key to the program's success.

The 2010 schedule will begin in the spring and will include a hands-on resource conservation kit for each student in Gil Campos' sixth grade Earth Science class, as well as a field trip to

the Mammoth Lakes Basin, a water treatment plant, a wastewater treatment plant and other special activities. This will be the fourth year of the program and to date nearly 300 Mammoth Lakes' students have participated in this approach to teaching water conservation and energy efficiency.

### Charges filed in Lakes Basin bear kill

Two misdemeanor counts have been filed against the Victorville man, Roy Flores, who killed a bear in the Mammoth Lakes Basin in August, according to Mono County District Attorney George Booth.

One count is for the unlawful taking of a bear with a firearm, a violation of the California Department of Fish and Game Code, and the second is for discharging a firearm within a prohibited area, a violation of Mammoth Lakes Town ordinances.

Booth said Flores was sent a notice to appear in the Mammoth Court on Dec. 21. — CB

### H1N1 flu vaccine update

All persons under the age of 25 and persons up to age 64 who have chronic disease conditions should now call the Mono County Health Dept. for an appointment to get their vaccine for H1N1.

All pregnant women and families with children under the age of six months should already have received their vaccine. If not, call for an appointment now. Children under age nine at all Mono County elementary schools will receive their second H1N1 vaccine within the next two weeks. Look for information from your child's school.

The priorities for distribution of vaccine are set by the Centers for Disease Control based on the groups at greatest threat for problems associated with the H1N1 flu. For more information, call the Mono County Health Dept. at (760) 924-1830.
